1. When used in conjunction with an approved B-0 Class ceiling.
2. "BIP AH25 B-0 Class Square Access Hatches" consisting of 0.6mm/1.0 mm thick steel sheet attached to 20mm x 30mm x 15mm x 1.6 mm thick steel frame using a continuous stainless steel hinge and fitted with push button lock w/latch (one for size 290mm x 290mm and two for size 590mm x 590mm).
3. Maximum size of "BIP AH25 B-0 Class Square Access Hatches": 590mm x 590mm; clear opening size: 560mm x 560mm.
4. Minimum size of "BIP AH25 B-0 Class Square Access Hatches": 290mm x 290mm; clear opening size: 260mm x 260mm.
5. Composition, application and installation of sub components, including any adhesives, seals and any fire retardants, to be maintained in production and use in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
6. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
7. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products, whether manufactured by themselves or their licensee manufacturers, if agreed by Lloyd's Register, are fully compliant with the relevant statutory regulations and Lloyd's Register Class rules as applicable and designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties .
