- 4. Minimum size of "BIP AH25 B-0 Class Square Access Hatches": 290mm x 290mm; clear opening size: 260mm x 260mm.

 retardants, to be maintained in production and use in accordance with originally tested composition formula and
 method of application and installation, and manufacturer's instructions.
- 6. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
