Product description

"BIP AH25: B-0 Class Access Hatch",

a ceiling access hatch composed of a hinged single hatch leaf with hatch frame and locking arrangement. The hatch may be fitted with one push button lock with latch for the smaller hatches and two push button locks with latch for larger hatches. All hatch sizes are fitted with a full length piano hinge.

The hatch leaf comes in two versions, composed either of 1 mm steel plate or 23.5 mm mineral wool (density 140 kg/m³, manufactured by KCC Corporation) covered with 0.6 mm steel plate on both sides.

The hatch frame is made of 1.6 mm steel plate and is fastened to the ceiling panel by overhead screws (Ø4x13).

For further details, see drawing listed under Type Examination documentation.

Application/Limitation

Approved for use as an integrated part of a horizontal fire retarding division of class B-0.

Approved for installation in the tested ceiling BIP C-643 from BIP Industries. Installation in other ceilings may be approved case-by-case. Ceiling has to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Maximum hatch size with two push button locks: 590 mm x 590 mm (W x L). Maximum hatch size with one push button lock: 290 mm x 290 mm (W x L).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
