"BIP C-161: B-0 Class Continuous Ceiling"

composed of panels suspended below the structural deck with T-carriers. Panels consist of 15 mm thick mineral wool (density 200 kg/m³, manufactured by KCC Corporation), covered with 0.6 mm thick galvanized steel sheet on one side.

The panels are connected to each other by fitting screws.

Total panel thickness: 30 mm
