THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION:

B-0 Class Continuous Ceilings - Type "BIP C-512"

Composed of steel cassettes suspended below the structural deck by means of steel angles and hanger sets fixed to the main runners. Panel cassettes consist of 25 mm thick "**Mineral Wool #60**" (nominal density 60 kg/m³; manufactured by KCC Corporation, Korea) covered with 0.6 mm thick galvanized perforated steel sheets (Ø 1.8 mm, 10 mm spacing) on the exposed side.

Ceiling panels are joined together on their longitudinal edges by means of connection profiles and lateral edges by means of connection clip screwed to the main runners (25 mm gap between panels) on the unexposed face.

Maximum span of main runners: 1400 mm

Maximum span of cross runners: 2500 mm

Maximum span of suspender (hanger set): 2500 mm

The ceiling framework is connected with bulkhead by means of 1 mm thick steel top profiles.

Maximum length of panels: 2240 mm (up to 5000 mm under responsibility of manufacturer's engineering specification)

Maximum width of panels: 300 mm

Total thickness of panels: 25 mm

Minimum distance between steel deck and ceiling: 300 mm

2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawings N° F2014-C512-R0 Rev.ORI dated 28/04/2014.

3. TEST REPORTS:

Test report N° AK2014-0283R dated 16/06/2014, as per IMO 2010 FTP Code Annex 1 Part 3, from FILK, Korea.

4. APPLICATION / LIMITATION:

4.1 - Approval is also valid for non-perforated or less perforated steel sheet without further testing.

4.2 - The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS:

5.1 - The **B-0 Class Continuous Ceilings - Type "BIP C-512"** are to be supplied by **BIP INDUSTRIES Co., Ltd.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **BIP INDUSTRIES Co., Ltd.** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.
