Product description

"BIP C-563: B-15 Class Continuous Ceiling"

composed of panels suspended below the structural deck. The panel consists of 50 mm thick mineral wool (manufactured by Keumkang Korea Chemical Co., Ltd., Korea) of 80 kg/m³ density, covered with 0.6 mm thick steel sheets on an exposed side.

The panels are connected together by a grillaged main T-bar and a cross T-bar and are fastened to the deck by a slot connection between hanger sets and the main T-bar.

Total ceiling thickness is 50 mm.

For further details, see the drawings mentioned under Type Examination documentation.

Application/Limitation

Approved for use as a horizontal fire retarding division of class B-15

Max. panel size is 610 mm x 610 mm (W x L).

Max. distance from a bulkhead to the main T-bar/hanger set: 1220 mm

Max. distance between hanger sets: 610 mm

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
