THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION:

B-0 Class Continuous Ceilings - Type "BIP C-613"

Composed of steel cassettes suspended below the structural deck by means of profiles and hangers. Panel cassettes consist of 25 mm thick "**Mineral Wool #60**" (nominal density 60 kg/m³; manufactured by KCC Corporation, Korea) supported by a pre-formed steel sheet 0.6 mm thick. This pre-formed steel sheet makes the longitudinal junction between panels. Junction between panels in length is made by means of 61.5 x 50 mm T-carrier made of 1 mm thick steel sheet bolted to steel cassettes and a 0.6 mm thick steel cap profile. T-carrier is also part with a hanger set of the hanging system.

The ceiling framework is connected with bulkhead by means of 1 mm thick steel top profiles.

Maximum length of panels: 2360 mm (up to 3000 mm under responsibility of manufacturer's engineering specification)

Maximum width of panels: 300 mm

Total thickness of panels: 25 mm

Minimum distance between steel deck and ceiling: 300 mm

2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawings N° C-613-B0-R0 Rev.ORI dated 07/08/2012.

3. TEST REPORTS:

Test report N° A2012-0618, dated 23/11/2012, as per IMO 2010 FTP Code Annex 1 Part 3, from FILK, Korea.

4. APPLICATION / LIMITATION:

4.1 - Approval is also valid for non-perforated or less perforated steel sheet without further testing.

4.2 - The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS:

5.1 - The **B-0 Class Continuous Ceilings - Type "BIP C-613"** are to be supplied by **BIP INDUSTRIES Co., Ltd.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **BIP INDUSTRIES Co., Ltd.** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.
