B-15 Class Continuous Ceilings - Type "BIP C-615"

Composed of steel cassettes suspended below the structural deck by means of hangers. The 50 mm thick panel cassettes are composed of a "**mineral wool**" board (nominal density 80 kg/m³, manufactured by KCC Co., Korea) covered with a 0.6 mm thick galvanized steel sheet on exposed side.

Ceiling panels are joined together longitudinal edges by means of T-carrier bolted to panel's steel sheet. T-carrier together with a hanger set form the hanging system.

Minimum distance between steel deck to ceiling:300 mmMaximum width of a panel:300 mmTotal thickness of bulkhead:50 mm
