CONDITIONS OF CERTIFICATION

- 1. Ceiling panel system consisting of: 0.6mm thick, 300mm wide galvanized steel sheet panels, insulated on the upper side with (50mm thick, 80 kg/m³ density) mineral wool manufactured by KCC Corporation, Korea.
- 2. Total ceiling thickness: 50mm.
- 3. Maximum ceiling panel size: 300 mm width.
- 4. Minimum distance between top of ceiling and bottom of overhead deck: 300mm.
- 5. Adjacent panels connected together longitudinally with overlapping joints and at ends with T carrier welded to deck above.
- 6. Maximum distance between hanger set: 900 mm.
- 7. Panels connected to bulkheads by steel profile to bulkhead and top steel profile screwed on top and secured with self-tapping screws, and to steel profiles suspended from deck with hanger sets.
- 8. Composition, application and installation of sub components, including any adhesives, seals and any fire retardants, to be maintained in production and use in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
- 9. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
- 10. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products, whether manufactured by themselves or their licensee manufacturers, if agreed by Lloyd's Register, are fully compliant with the relevant statutory regulations and Lloyd's Register Class rules as applicable and designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties.
