

## Product description

"BIP C-645 / B-15 Class Continuous ceiling"  
composed of an insulation core made of 40 mm thick mineral wool (manufactured by KCC Corporation, Korea) of nominal density 80 kg/m<sup>3</sup> put on the 0.6 mm thick perforated or non-perforated steel sheets with "Non-woven fabric" (manufactured by Dae Kyoung Chemical Co., Ltd.).

The ceiling panels are joined together with an insert type profile system and connected to deck with P754 Hanger sets and T-carriers.

Total ceiling panel thickness is 45 mm.

## Application/Limitation

Approved for use as a horizontal continuous fire retarding division of class B-15.

Max. panel size is 300 mm x 2360 mm (W x L).

Max. distance between T-carriers: 2360 mm

Max. distance between Hanger sets: 1200 mm

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
