Product description

"BIP F-A60S: A-60 Class Floating Floor"

Composed of structural steel deck covered with "BIP F-A60S" floating floor. The floating floor is composed of 50 mm thick Mineral Wool manufactured by KCC Corporation, density 240 kg/m³, covered with 3.2 mm thick steel, constructed of 1800 x 590 mm (width x length) steel sheets joined together spot welding and 1.6 mm thick locking pieces (L-shaped, 20x20x10 mm). The welding spots are spaced about 300 mm apart. The insulation is glued to the steel sheets with an adhesive.

Total thickness of floating floor is 53.2 mm.

For further details see approved drawings listed under Type Examination documentation below.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
