<u>1. PRODUCT DESCRIPTION :</u>

B-15 Class Bulkheads - Type "BIP W-151S"

Composed of 23.5 mm thick insulating mineral wool (nominal density approx. 140 kg/m³, manufactured by KCC Co., Ltd.) glued* on both sides with 0.6 mm thick steel sheets. Panels' vertical edges are reinforced with 0.6 mm thick steel M-profile. Each panel is jointed together with 3 mm thick steel spline joint profile.

* Urethane adhesive: "OCUA-1000RC", manufactured by DAI HAN POLYMER Ind. Co., Ltd., or "BNUR-1000", manufactured by BN Chemical Co., Ltd., maximum application rate 200 g/m².

Maximum width of a panel: 600 mm Total thickness of panel: 25 mm

2. DOCUMENTS AND DRAWINGS :

As per the Manufacturer's drawing N° F2015-W151S-R0 dated March 30, 2015.

3. TEST REPORTS :

Test report N° AK2015-0301 dated June 8, 2015 (testing date: April 23, 2015) as per IMO 2010 FTP Code, Annex 1, Part 3 from FILK, Korea.

4. APPLICATION / LIMITATION :

4.1 - The fitting aboard to be the same as used for the test.

4.2 - The following components have to be covered by a valid type approval certificate, issued by the Society:

- the insulating material "Mineral wool #140"
- the adhesives "OCUA-1000RC" and "BNUR-1000"
- any added finish surface material(s).

5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The "BIP W-151S" are to be supplied by BIP Industries Co., Ltd. in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **BIP Industries Co., Ltd.** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.
