- 2) The panels are connected each other by spline joint profile(3 mm thick, 30 mm wide).
- The mineral wool is bonded to steel sheets with urethane adhesive "OCUA-1000RC" manufactured by Dae Han Polymer Co., Ltd, "BNUR-1000" manufactured by BN Chemical Co., Ltd.
- 4) Total thickness : 25 mm
- 5) Max. panel size : 600 mm x 2500 mm (W x H)
- 2. Approved Drawings : No. F2015-W151S-R0 (5 pages includnig cover)
- 3. Approval Conditions
- 1) This approval is granted on the basis of the test report no. AK2015-0301 dated on 08th June 2015 issued by Fire Insurers Laboratories of Korea(FILK).
