Product description

"BIP W-151S: B-15 Class Bulkhead"

Composed of panels comprised of approx. 25 mm thick mineral wool (manufactured by KCC Corporation, Korea) of density 140 kg/m³ and faced on both sides with 0.6 mm thick steel sheets and urethane adhesive manufactured by Dae Han Polymer CO., LTD. and BN Chemical CO., LTD., is used for the fixation of insulation material. Vertical joint edges of the panel are reinforced with 0.6 mm thick steel M-profile.

The panels are joined together by means of spline profile joints.

Total panel thickness is 25 mm.

For further details, see the drawings listed under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15

Max. Panel size: 600 mm x 2500 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
