## **CONDITIONS OF CERTIFICATION**

- Vertical sandwich interlocking panel system 'BIP W-151SD' consisting of: two vertical panels with an air gap 25mm thick in-between. Each panel consists of: outer side 0.6 mm thick galvanised steel sheet and inner side 0.6mm thick perforated galvanised steel sheet bonded to an insulation core (23.5 mm thick, 140 kg/m³ density) mineral wool insulation manufactured by KCC Corporation using urethane adhesive 'OCUA-1000RC' manufactured by Dae Han Polymer Ind Co. Ltd. or 'BNUR-1000' manufactured by BN Chemical Co., Ltd.
- 2. Maximum width of panels: 600mm wide
- 3. Total thickness of panel system: 75mm
- 4. Adjacent panels connected together longitudinally with spline joints with 0.5mm thick steel supporting channels.
- 5. Panels secured along perimeter of bulkhead by screws into steel channel 2.3mm thick, dimensions 40mm x 82mm x 40mm. Channel secured by welding to fixing cleats.
- 6. For use in escape routes in ro-ro passenger ships, B Class bulkhead panel system is to be subjected to strength tests where handrails are to be attached, in accordance with IMO MSC/Circ.910 under independent witness and test reports submitted to final design Project Approval Authority for approval on a case-by-case basis.
- 7. Composition, application and installation of sub components, including any adhesives, seals and any fire retardants, to be maintained in production and use in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
- 8. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
- 9. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products, whether manufactured by themselves or their licensee manufacturers, if agreed by Lloyd's Register, are fully compliant with the relevant statutory regulations and Lloyd's Register Class rules as applicable and designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties .
