Product description

"BIP W-151SD: B-15 Class Bulkhead"

is composed of two insulated steel panels mounted with a 25 mm air gap between them. Each panel is made of 23.5 mm thick mineral wool manufactured by KCC Corporation with nominal density of 140 kg/m³ faced on both sides with 0.6 mm thick galvanized steel plates (bonded with adhesive). The steel plates facing the air gap are perforated, while the plates facing outwards have a smooth finish. Vertical edges of both sides of the panel are reinforced with 0.6 mm steel support channel. Bulkhead sections are connected together using spline joint profiles (3 x 30 mm).

Total bulkhead thickness is 75 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 600 mm x 2480 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
