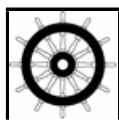

Product description

"BIP W-161: B-0 Class Bulkhead",
composed of panels faced on one side with 0.6 mm steel sheet, insulated with 15 mm mineral wool (density 200 kg/m³, manufactured by KCC Corporation). A urethane adhesive OCUA-1000RC (manufactured by Dae Han Polymer) or BNUR-1000 (manufactured by BN Chemical) is used for the fixation of the insulation material. The panels are fitted together by omega profiles with fitting screws (ø4 x 20L, pitch 300 mm).

Total panel thickness: 30 mm (including wrapped edge).

For further details, see drawings listed under Type Examination documentation.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-0.

Maximum panel size: 600 mm x 2500 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
