THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION:

B-15 Class Bulkheads - Type "BIP W-162"

Composed of a 0.6 mm thick galvanized steel sheet cassette filled with two layered mineral wool boards (density 200 kg/m³, manufactured by KCC Co., Ltd., Korea) glued to the steel cassette with adhesive "OCUA 1000RC" (maximum application rate 200 g/m², manufactured by DAI HAN POLYMER Ind. Co., Ltd.) or "BNUR-1000" (maximum application rate 200 g/m², manufactured by BN Chemical Co., Ltd.).

Two adjacent panels are connected by 1.2 mm thick omega profile (10 x 15 x 52.4 x 15 x 10 mm) with fixing screws on insulation side. Insulation material is filled between connecting profile and panels as well.

Total thickness of the panel: 30 mm

Maximum size of the panel: 600 mm x 2410 mm (w x h)

2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawing N° W-162-B15-R0, rev. ORI dated March 6, 2012.

3. TEST REPORTS:

Test report N° KOMERI-0402-12T579 dated September 5, 2012 (testing date: August 30, 2012) as per IMO 2010 FTP, Code, Annex 1 Part 3 issued from KOMERI, Korea.

4. APPLICATION / LIMITATION:

- 4.1 The fitting aboard to be the same as used for the test.
- 4.2 The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:
- the insulating material, "mineral wool board #200 (nominal density 200 kg/m³)",
- the adhesives "OCUA 1000RC" and "BNUR-1000",
- any added finish surface material(s).

5. PRODUCTION SURVEY REQUIREMENTS:

- 5.1 The "BIP W-162" are to be supplied by BIP Industries Co., Ltd. in compliance with the type described in this certificate.
- 5.2 This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.
- 5.3 *BIP Industries Co., Ltd.* has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.
