Product description

"BIP W-163 / B-15 Class Bulkhead"

composed of two panels facing each other with their insulated side, separated by steel channel profiles (30 mm x 20 mm x 50 mm, 2.3 mm thick). Each panel consists of 0.6 mm thick galvanized steel sheets and it is insulated with 15 mm thick mineral wool of density 200 kg/m³ (manufactured by KCC Corporation, Korea). Total thickness of each panel is 30 mm. The distance between the two panels is 20 mm, making an air gap between the insulation layers of 50 mm.

Each panel is fitted on square pipe made of 2.1 mm thick steel box (30 mm x 30 mm).

The mineral wool is glued to the steel sheets with an adhesive.

The panels are fitted together by Ω-profiles with fitting screws (ø4 x 16L, pitch: 300 mm).

Total bulkhead thickness is 80 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max. panel size is 600 mm x 2480 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
