#### **Product description**

"BIP W-202S B-15 Class Bulkhead"

composed of panels made of 0.4 mm galvanized steel sheets insulated with 48.5 mm mineral wool with density 140 kg/m³ manufactured by KCC Corporation. The insulation is glued on the steel sheets. The panels are fitted into each other with a spline joint profile as per drawing F2016-W202S-R0.

Max. panel thickness: 50 mm.

#### **Application/Limitation**

Approved for use as a vertical fire retarding division of class B-15.

Max panel size: 2480 mm x 600 mm (H x W).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
