THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION :

B-15 Class Bulkhead Panels - Type "BIP W-302SE"

Composed of panels consisting in two x (0.6 mm thick galvanized + 0.4 mm perforated steel sheets) fitted with two mineral wool boards (density 140 kg/m³, manufactured by KCC Co., Ltd. Korea) and air-gap in-between the mineral wool boards (5 mm depth).

Vertical edges of panel are reinforced with 50 mm thick x 50 mm width mineral wool boards (density 240 kg/m³, manufactured by KCC Co., Ltd. Korea).

The mineral wool boards are glued to the steel sheets with adhesive "OCUA-1000RC" (manufactured by DAI HAN POLYMER Ind. Co., Ltd., maximal application rate: 200 g/m²).

Alternative glue: "BNUR-1000" (maximal application rate: 200 g/m²; manufactured by BN Steel Chemical Co., Ltd.).

The panels are jointed each other by means of 0.6 mm thick removable cap profiles.

Maximum width of panel: 550 mm

Total thickness of panel: 50 mm

2. DOCUMENTS AND DRAWINGS :

As per the Manufacturer's drawing N° F2014-W302SE-R0, rev.ORI. dated Jan. 29, 2014.

3. TEST REPORTS :

Test report N° AK2014-0070 issued on Apr. 11, 2014 (test date: Feb. 28, 2014) as per IMO 2010 FTP Code, Annex 1, Part 3 from FILK, Korea.

4. APPLICATION / LIMITATION :

The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The **B-15 Class Bulkheads - Type "BIP W-302SE"** are to be supplied by **BIP INDUSTRIES CO., LTD.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.
