Product description

"BIP W-308E B-15 Class Bulkhead"

composed of 0.6 mm galvanized and 0.4 mm perforated steel sheets on each side of a 48 mm thick mineral wool core (manufactured by KCC Corporation) of density 140kg/m^3 with a 50 x 20 mm (width x height) air gap arranged along vertical direction of the panel inside, spaced every 100 mm.

The panels are joined together by means of male/female connections.

Total bulkhead panel thickness is 50 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max panel size: 600 x 2480 mm (W x H)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
