THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION:

B-0 Class Bulkheads - Type "BIP W-351"

The 25 mm thick panels are composed of a "**mineral wool**" board (density 140 kg/m³, manufactured by KCC Co., Ltd.) glued on both side with two 0.6 thick steel sheets by adhesive "**OCUA-1000RC**" (maximal application rate: 200 g/m²; manufactured by DAE HAN POLYMER Ind. Co., Ltd.)

Alternative glue: "**BNUR-1000**" (maximal application rate: 200 g/m²; manufactured by BN Steel Chemical Co., Ltd.).

The panels are connected on one side (exposed side of the bulkhead) by connector clip joints.

Maximum width of a panel: 550 mm

Total thickness of bulkhead: 25 mm

2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawings N° F2013-W351-R0 dated 31/07/2013.

3. TEST REPORTS:

Test report N° AK2013-0238 dated 04/11/2013, as per IMO 2010 FTP Code Annex 1 Part 3, from FILK, Korea.

4. APPLICATION / LIMITATION :

4.1 - **Restricted application:** The use is restricted to application where fire hazard has been identified as coming from the side including the connector clip joints.

4.2 - The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS:

5.1 - The **B-0 Class Bulkheads - Type "BIP W-351"** are to be supplied by **BIP INDUSTRIES CO., LTD.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **BIP INDUSTRIES CO., LTD.** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.
