# **Product description**

"BIP W-351(B15) B-15 Class Bulkhead" consists of panels composed of one layer of 23.5 mm thick mineral wool insulation of 140 kg/m<sup>3</sup> density (produced by KCC Corporation) covered on both sides by 0.6 mm thick steel sheets. Insulation is glued to the steel sheets by means of polyurethane adhesives of BNUR-1000 and OCUA-1000RC types.

The panels are connected with removable CAP and angle Profiles.

Total panel thickness: 25 mm

For further details see drawing listed under Type Examination documentation.

#### **Application/Limitation**

Approved for use as a vertical fire retarding division of class B-15.

Max. panel size is 600 mm x 2480 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
