

Product description

"BIP W-358 B-15 Class Bulkhead"

The bulkhead panel composed of an insulation core made of 23.5 mm thick mineral wool manufactured by KCC Corporation Ltd., Korea, of nominal density 140 kg/m³ bonded to 0.6 mm steel plates on each side. Panels are fitted together by "tongue and groove" patterns on the panel sides.

Total bulkhead panel thickness is 25 mm.

For further details, see drawing listed under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 2480 x 580 mm (H x W).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
