Product description

'BIP W-A60(A-60) Class Bulkhead'

Bulkhead constructed of a 50 mm thick mineral wool insulation core with density of 140 kg/m³ (manufactured by KCC CORPORATION), with on both sides a panel construction. Each panel is composed of a 23.5 mm thick mineral wool insulation core with density of 140 kg/m³ (manufactured by KCC CORPORATION) with 0.6 thick galvanized steel sheets on both sides fixed by means of an adhesive. The panels are connected with spline joint profiles which is fitted into a 0.5 mm thick M-profile.

Total bulkhead thickness: 100 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

Max. size of panel: 600 mm x 2980 mm (W x L)

The insulation materials and adhesives used have to be approved in accordance with the Marine Equipment Directive and bear the MED Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
