#### **CONDITIONS OF CERTIFICATION**

- Vertical sandwich interlocking panel system "BIP W-E80R" consisting of: vertical panels of 0.6 mm thick galvanised steel sheet bonded on both sides of an insulation core (48.5mm thick, 140 kg/m³ density) mineral wool insulation manufactured by KCC Corporation using urethane adhesive 'OCUA-1000RC' manufactured by Dea Han Polymer Ind. Co. or 'BNUR-1000' manufactured by BIP Chemical Co., Ltd.
- 2. Panels incorporate longitudinal cable conduits consisting of 0.6mm thick steel, dimensions 2480 mm long from top edge of panel x 80mm width x 22mm deep, located centrally along width of panel and at unexposed face of panel.
- 3. Maximum bulkhead panel width: 550 mm.
- 4. Total thickness of bulkhead: 50 mm.
- 5. Adjacent panels connected together longitudinally with 0.6mm thick steel cap profile joints.
- 6. Panels secured by along edges within 1.0mm thick steel channel frame system. Channel secured by welding to fixing cleats.
- 7. For use in escape routes in ro-ro passenger ships, B Class bulkhead panel system is to be subjected to strength tests where handrails are to be attached, in accordance with IMO MSC/Circ.910 under independent witness and test reports submitted to final design Project Approval Authority for approval on a case-by-case basis.
- 8. Composition, application and installation of sub components, including any adhesives, seals and any fire retardants, to be maintained in production and use in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
- 9. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
- 10. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products, whether manufactured by themselves or their licensee manufacturers, if agreed by Lloyd's Register, are fully compliant with the relevant statutory regulations and Lloyd's Register Class rules as applicable and designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties.
