# **Product description**

"B-15 Class Bulkhead of type: BIP W-E80R"

composed of 0.6 mm galvanized steel sheets on each side of a 48.5 mm thick mineral wool core (manufactured by KCC Corporation) of density 140 kg/m³ and adhesive type OCUA-1000RC manufactured by Dae-Han Polymer or BNUR-1000 manufactured by BN Chemical is used for the fixation of insulation and steel sheets. A 0.6 mm thick cable conduit channel (manufactured by Seah Coated Metal) of 80 mm x 22 mm x 2480 mm (W x H x L) can be fitted in the middle of the panel.

The panels are joined together with a "Removable cap profile".

Total bulkhead panel thickness is 50 mm.

## Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max panel size: 550 mm x 2480 mm (W x H)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
