## THE SCHEDULE OF APPROVAL

#### 1. PRODUCT DESCRIPTION:

#### B-15 Class Aluminium Wall Panels - Type "BIP WA-402S"

The bulkhead consists of panels composed of "mineral wool #140" board (nominal density 140 kg/m³, manufactured by KCC Co., Ltd., Korea), bonded on both sides with 0.6 mm thick aluminium sheets by polyurethane adhesive "OCUA-1000RC" (application 0.15 mm; manufactured by DAE HAN POLYMERS Ind. Co. KOREA) or "BNUR-1000" (maximal application rate: 200 g/m²; manufactured by BN Steel Chemical Co.,Ltd.).

Panels are jointed to each other by steel M-profiles (18 x 48.5 x 18 mm, 0.5 mm thick) forming a groove in which steel spline joint profile (30 x 3 mm) is inserted.

Top and bottom fixing of the panels is made by steel U-profiles (40 x 57 x 40 mm, 2.3 mm thick).

Tested length of panel: 2500 mm

Maximum width of panel: 600 mm

Total thickness of a panel: 50 mm

#### 2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawings N° F2024-WA402S-R0 dated 16/08/2024.

#### 3. TEST REPORTS:

Test report  $N^{\circ}$  KOMERI-0402-24T3378(E) dated 09/12/2024, as per IMO 2010 FTP Code, Annex 1, Part 3, from KOMERI, Korea.

#### 4. APPLICATION / LIMITATION:

The fitting aboard to be the same as used for the test.

#### **5. PRODUCTION SURVEY REQUIREMENTS:**

- 5.1 The **B-15 Class Aluminium Wall Panels Type** "**BIP WA-402S**" are to be supplied by **BIP INDUSTRIES Co., Ltd.** in compliance with the type described in this certificate.
