## THE SCHEDULE OF APPROVAL

### 1. PRODUCT DESCRIPTION:

#### **B-0 Class Aluminium Wall Panels - Type "BIP WA-451S"**

Consists of panels composed of "**mineral wool #140**" board (nominal density 140 kg/m<sup>3</sup>, manufactured by KCC Corporation, Korea), bonded on both sides with 0.6 mm thick aluminium sheets by polyurethane adhesive "**OCUA-1000RC**" (application 0.15 mm; manufactured by DAE HAN POLYMERS Ind. Co. KOREA) or "**BNUR-1000**" (maximal application rate: 200 g/m<sup>2</sup>; manufactured by BN Steel Chemical Co.,Ltd.).

Panels are jointed to each other by steel M-profiles (18 x 23.5 x 18 mm, 0.5 mm thick) forming a groove in which steel spline joint profile (30 x 3 mm) is inserted.

Top and bottom fixing of the panels is made by steel U-profiles (40 x 32 x 40 mm, 2.3 mm thick).

Tested length of panel:	2500 mm
Maximum width of panel:	600 mm
Total thickness of a panel:	25 mm

### 2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawings N° F2024-WA451S-R0 dated 16/08/2024.

### 3. TEST REPORTS:

Test report N° KOMERI-0402-24T4353(E) dated 13/01/2025, as per IMO 2010 FTP Code, Annex 1, Part 3, from KOMERI, Korea.

### 4. APPLICATION / LIMITATION:

The fitting aboard to be the same as used for the test.

### 5. PRODUCTION SURVEY REQUIREMENTS:

5.1 - The **B-0 Class Aluminium Wall Panels - Type "BIP WA-451S"** are to be supplied by **BIP INDUSTRIES Co., Ltd.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.
