Thickness 0.6 mm Aluminum Sheet faced on both side, Insulation (Mineral wool, Nominal density: 140 kg/m^3, Nominal thickness: 48.5 mm).

Bulkhead panel size (600 mm (W) x 2480 mm (H) x 50.0 mm (T) with Cable conduit way (80 mm (W) x 24 mm (D)).

The panels are joined together with spline-profiles.
