

Product description

"BIP WA-E80S(B-15) Class Bulkhead"

Is the bulkhead composed of one layer of 48.5 mm thick mineral wool insulation of 140 kg/m³ density (produced by KCC Corporation) covered on both sides by 0.6 mm thick aluminium sheets.

Insulation is glued to the aluminium sheets by means of polyurethane adhesives of BNUR-1000 and OCUA-1000RC types.

The panels are connected using 0.5 mm thick M-profile and 3 mm thick spline joint.

The panel is equipped with 80 mm x 22 mm of one longitudinal cable conduct inside.

Total panel thickness: 50 mm

For further details see drawing listed under Type Examination documentation.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 600 mm x 2480 mm (W x H)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
