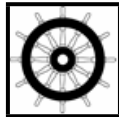

Product description

"BIP W-100R"

consists of bulkhead panels insulated with 98.5 mm thick Mineral Wool (140 kg/m³, manufactured by KCC Corporation). Along the vertical sides of the panel, Mineral Wool (240 kg/m³, manufactured by KCC Corporation) is fitted from the edge and 50 mm into the panel. The insulation is fixed to 0.6 mm thick steel sheets by means of adhesive.

Total panel thickness is 100 mm.

The panels are joined together with cap profiles on both sides and fitted to 1.2 mm thick steel profiles at the bottom and top. The top profile is fitted with 25 mm Mineral Wool (140 kg/m³, manufactured by KCC Corporation).

Application/Limitation

Approved for use as a non-load bearing vertical fire retarding division of class A-60.

Max. panel size: 600 x 3000 mm (W x H).

The use of this product shall be limited to applications specifically approved by the Administration in question, see IMO 2010 FTP Code Annex 1, Part 3, Items 1.12 and 1.13. The construction shall in any case not be used as part of main fire zone bulkheads and stairways enclosures on passenger ships (see also IMO MSC/Circ.1005).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
