#### **CONDITIONS OF CERTIFICATION**

- Vertical interlocking panel system consisting of: 0.6mm thick galvanised steel sheet panels each side of an insulation core (48.5mm thick, density 140 kg/m<sup>3</sup>) mineral wool manufactured by KCC Corporation, Korea and density 240kg/m<sup>3</sup> within joints. Bonded with adhesives 'OCUA-1000RC' manufactured by DAI HAN POLYMER Co., Ltd and 'BNUR-1000' manufactured by BN STEEL CHEMICAL Co., Ltd.
- 2. Total thickness of bulkhead system: 50mm
- 3. Maximum width of panels: 600mm
- 4. Adjacent panels connected together longitudinally with spline joints 30mm wide x 3mm thick.
- 5. Installation: panels to be secured as per fire test condition.
- 6. For use in escape routes in ro-ro passenger ships, B Class bulkhead panel system is to be subjected to strength tests where handrails are to be attached, in accordance with IMO MSC/Circ.910 under independent witness and test reports submitted to final design Project Approval Authority for approval on a case-by-case basis.
- 7. Composition, application and installation of sub components, including any adhesives, seals and any fire retardants, to be maintained in production and use in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
- 8. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
- 9.
