- 1. Product Descriptions
- The bulkhead consists of panels having 50 mm thick mineral wool insulation(140 kg/m²) covered with 0.6 mm thick galvanized steel sheet on both sides.
   (Adhesive : BNUR-1000, BN Chemical Co., Ltd.)
- 2) The panels are connected each other by spline joint profile (3 mm thick, 30 mm wide).
- 3) Total thickness: 50 mm
- 4) Max. panel size : 600 mm x 2480 mm (W x H)
- 2. Approved Drawings : No. F2012-W102S-R0 (1/5  $\sim$  5/5)
- 3. Approval Conditions
- 1) This approval is granted on the basis of the test reports no. A2012-0930 dated on 20th. Feb. 2013 from Fire Insurers Laboratories of Korea (FILK).
- 2) The surface materials, if applied, shall be of type approved by the Society.
- 3) In case where the panel is penetrated to incorporate light fixture and similar devices, arrangement shall be made to ensure that the fire resistance is not impaired.
- 4) The product or packing is to be marked with manufacturer name and type designation on a suitable position.
- 5) Any adhesives used in A or B Class divisions should be low flame spread.
- 6) Individual Product Certification is not required.
- 7) This approval does not cover the airborne sound insulation properties.
- 8) Approval Certificate for Manufacturer (Cert. no. : CSP00745-PA001) is to be retained validly apart from this Approval.
