THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION :

B-15 Class Bulkhead Panels - Type "BIP W-102SH"

The 50 mm thick bulkhead panel is composed of:

- two (2) x 0.6 mm thick galvanised steel sheets,
- 23.5 mm thick x two layers of insulation core (nominal density 140 kg/m³; manufactured by KCC Corporation, Korea) glued to the steel plates with adhesive type "BNUR-1000" (applicable rate: 200 g/m²; manufactured by BN Steel Chemical Co., Ltd.) or "OCUA-1000RC" (applicable rate: 200 g/m²; manufactured by Dai Han Polymer Ind. Co., Ltd.)

The panels are connected to each other by 3 mm thick spline joints inserted in M-profiles (0.5 mm thick galvanized steel, 18x48.5x18 mm) located on the edges of panels.

The panels are connected to the surrounding ship structure by L steel angles (50x50x5 mm) and screws.

Maximum width of panel: 600 mm

Height of tested panel: 2460 mm

Total thickness of panel: 50 mm

2. DOCUMENTS AND DRAWINGS :

As per the Manufacturer's drawing N° F2021-W102SH-R1, rev.R1 dated Jan. 10, 2022.

3. TEST REPORTS :

Test report N° AK2022-0124 issued on Apr. 22, 2022 (test date: Mar. 24, 2022) as per IMO 2010 FTP Code, Annex 1, Part 3 from FILK, Korea.

4. APPLICATION / LIMITATION :

The fitting aboard should be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The "**BIP W-102SH**" are to be supplied by **BIP INDUSTRIES CO., LTD.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **BIP INDUSTRIES CO., LTD.** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.

5.4 - The following components have to be covered by a valid type approval certificate, issued by the Society:

- the insulating material "**Mineral wool #140**"
- the adhesives "**OCUA-1000RC**" or "**BNUR-1000**"
- any added finish surface material(s).

6. MARKING OF PRODUCT :

The product or packing is to be marked with Manufacturer name, type designation and fire-technical rating.

7. OTHERS :

It is **BIP INDUSTRIES CO., LTD.**'s responsibility to inform shipbuilders or their sub-contractors of the proper methods of fitting, use and general maintenance of the approved equipment and the conditions of this approval.
