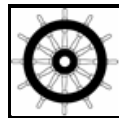

## Product description

"BIP W-106S: B-15 Class Bulkhead"

composed of two layers of mineral wool (manufactured by KCC Corporation) of 140 kg/m<sup>3</sup> density, divided by 0.6 mm thick perforated steel sheet with 6 mm air space between the layers, faced on both sides with 0.6 mm steel sheet. A urethane adhesive manufactured by Dae Han polymer Co., Ltd. and BN Chemical Co., Ltd. is used for the fixation of the insulation material.

Vertical joint edges of the panel are reinforced with 0.6 mm thick galvanized steel support channel and filled with 50 mm wide mineral wool of 240 kg/m<sup>3</sup> density.

The panels are joined together by means of spline profile joints.

Total panel thickness is 50 mm.

For further details, see the drawings listed under Type Examination documentation below.

## Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum size of panels: 600 mm x 2500 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
