THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION:

B-15 Class Bulkheads - Type "BIP W-106SE(6)"

Composed of two 0.6 mm thick galvanized + 0.4 mm thick perforated (Ø 4 mm, pitch 8.5 mm) steel sheets (manufactured by POSCO, Korea) bonded thanks to "OCUA-1000 RC" urethane adhesive (manufactured by DAE HAN POLYMERS IND. Co. KOREA) to a "MINERAL WOOL" board (nominal density 140 kg/m³, manufactured by KCC Co., Ltd., Korea) and separated by a 5 mm thick air gap between each mineral wool board.

Vertical edges of panels are jointed each other by a steel spline joint profile (3 mm thick, 30 mm long).

The bulkhead is fixed:

- on each vertical and horizontal edge, by a 2.0 mm thick U-profile steel channel (40 mm x 56 mm x 40 mm) and fitting screws (pitch: 300 mm) and,
- on the frame, by 5 mm thick L-profile fixing cleats (50 x 50 x 100 mm).

Maximum width of panel: 600 mm

Total thickness of bulkhead: 50 mm

2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawing N° W-106SE(6)-R0 dated 02/11/2012.

3. TEST REPORTS:

Test report N° A2012-0931, dated 20/02/2013, as per IMO 2010 FTP Code Annex 1 Part 3, from FILK, Korea (testing date: 29/11/2012).

4. APPLICATION / LIMITATION:

4.1 - The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:

- the insulating material(s) "MINERAL WOOL, density 140 kg/m³",
- the adhesive material "OCUA-1000 RC",
- any added finish surface material(s).

4.2 - The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS:

5.1 - The **B-15 Class Bulkheads - Type "BIP W-106SE(6)"** are to be supplied by **BIP INDUSTRIES Co., Ltd.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **BIP INDUSTRIES Co., Ltd.** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.
