## THE SCHEDULE OF APPROVAL

### 1. PRODUCT DESCRIPTION :

#### **B-15 Class Bulkheads - Type "BIP W-106SE(A)"**

Composed of two x (0.6 mm galvanized + 0.4 mm perforated steel sheets) and an insulating core made up of mineral wool boards (nominal density 140 kg/m<sup>3</sup>, manufactured by KCC Co., Ltd.). Mineral wool board is glued to the steel sheets with adhesive "OCUA-1000RC" (manufactured by DAI HAN POLYMER Ind. Co., Ltd., maximum application rate 200 g/m<sup>2</sup>) or "BNUR-1000" (manufactured by BN Chemical Co., Ltd., maximum application rate 200 g/m<sup>2</sup>).

Panels are connected by M-profile with spline joint profile (3 mm thick, 30 mm width).

The panels are connected to the surrounding structure by 2 mm thick steel U-profiles (40 x 55 x 40 mm) with screws.

A panel may be fitted with an air gap (50 mm x 20 mm, width x depth) used for pre-cables conduits (minimum distance between air gap in the panel: 50 mm).

Max. panel size (width): 600 mm

Total bulkhead thickness: 50 mm

### 2. DOCUMENTS AND DRAWINGS :

Panel & pre-cable conduit panel: as per the Manufacturer's drawing N° W-106SE-R0, rev.ORI dated May 21, 2012.

### 3. TEST REPORTS :

Test report N° AK2012-0185 dated Aug. 20, 2012 (testing date: June 22, 2012) as per IMO FTP Code, Annex 1, Part 3 from FILK, Korea.

### 4. APPLICATION / LIMITATION :

4.1 - The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:

- the insulating material "**Mineral wool Board #140**"
- the adhesives "**OCUA-1000RC**" or "**BNUR-1000**"
- any added finish surface material(s)

4.2 - The fitting aboard to be the same as used for the test.

### 5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The "**BIP W-106SE(A)**" are to be supplied by **BIP Industries Co., Ltd.** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **BIP Industries Co., Ltd.** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.
