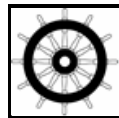

## Product description

"BIP W-161: B-0 Class Bulkhead"

composed of panels faced on an exposed side with 0.6 mm steel sheet, insulated with 15 mm thick mineral wool from KCC Corporation Korea of 200 kg/m<sup>3</sup> density. A urethane adhesive, manufactured by Dae Han polymer Co., Ltd. and BN Chemical Co., Ltd. is used for the fixation of an insulation material. The panels are fitted together by Ω-profiles with fitting screws (ø4 x 20L, pitch: 300 mm).

Total thickness of panels: 30 mm (including wrapped edge)

## Application/Limitation

Approved for use as a vertical fire retarding division of class B-0.

Maximum size of panels: 600 mm x 2500 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
