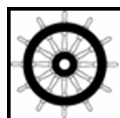

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the United States of America and the EEA EFTA states on the mutual recognition of Certificates of Conformity for Marine Equipment" signed 17 October 2005, and amended by Decision No 1/2019 dated February 22nd, 2019.

### Product description

"BIP W-302S: B-15 Class Bulkhead"

Consists of interlocking bulkhead panels constructed of 48.5 mm thick mineral wool manufactured by KCC Corporation, density 140 kg/m<sup>3</sup>, faced on both sides with 0.6 mm thick steel sheets (bonded with adhesive). There is a corrugated 0.6 mm thick, 485 mm wide, perforated steel plate in the centre of the insulation core.

Panel thickness is 50 mm.

Panels are connected to each other by removable cap profiles on both panel sides.

For further details see approved drawings listed under Type Examination documentation below.

### Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max panel size: 550 mm x 2480 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
