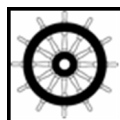

Product description

"BIP W-308: B-15 Class Bulkhead"

Consist of an insulation core made of 48.5 mm thick mineral wool of nominal density 140 kg/m³ manufactured by KCC Corporation, glued to 0.6 mm thick steel sheets on both sides.

The panels are joined together by means of "tongue and groove" patterns on the panel sides.

Total panel thickness is 50 mm.

For further details see approved drawings listed under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max panel size: 600 mm x 2480 mm (width x height).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
