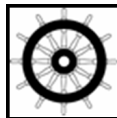

### **Product description**

"BIP W-351 B-0 Class Bulkhead"

composed of 0.6 mm galvanized steel sheets on each side of a 25 mm thick mineral wool core (manufactured by KCC Corporation) of density 140kg/m<sup>3</sup>.

The panels are joined together with a "Removable cap profile".

Total bulkhead panel thickness is 25 mm.

### **Application/Limitation**

Approved for use as a vertical fire retarding division of class B-0.

Max panel size: 540 x 2480 mm (Width x Height).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
