CONDITIONS OF CERTIFICATION

1. "BIP W-351" B-0 Class Bulkhead Panel comprises: 0.6mm thick, 540mm wide galvanised steel facing sheets fitted to both sides of (25mm thick, 140kg/m³ density) mineral wool insulation manufactured by KCC Corporation Korea.
2. Adjacent panels joined together by 0.6mm thick x 10mm wide x 14mm deep steel cap profiles over panel end profiles on one side.
3. All panels are to be secured at the top and bottom railings and at end vertical boundaries with self-tapping steel screws at 300mm centres, to prevent movement.
4. For use in escape routes in ro-ro passenger ships, B Class bulkhead panel system is to be subjected to strength tests where handrails are to be attached, in accordance with IMO MSC/Circ.910 under independent witness and test reports submitted to final design Project Approval Authority for approval on a case-by-case basis.
5. Composition, application and installation of sub components, including any adhesives, seals and any fire retardants, to be maintained in production and use in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
6. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
7. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products, whether manufactured by themselves or their licensee manufacturers, if agreed by Lloyd's Register, are fully compliant with the relevant statutory regulations and Lloyd's Register Class rules as applicable and designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties.
