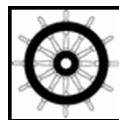

Product description

"BIP W-351D / B-15 Class Bulkhead"

composed of two 25 mm panels and each panel is faced on inner side with 0.6 mm thick perforated galvanized steel sheets and outer side with 0.6 mm thick galvanized steel sheet and an insulated core of 25 mm thick mineral wool of density 140 kg/m³ (manufactured by KCC Corporation, Korea). The two panels are fitted together and with 50 mm thick insulation in the middle with the same type of insulation as described above with a density of 60 kg/m³.

The mineral wool is glued to the steel sheets with an adhesive.

The panels are connected with a cap profile joint.

Total bulkhead thickness is 100 mm.

For further details see drawings listed under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max. panel size is 540 mm x 2480 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
